1. Introductions
2. Approval of minutes – **minutes approved**
3. JJC Chairman's report
 - **JJC Student Award updates: Selected student led the Pledge of Allegiance at the June Kane County Board meeting and was recognized with a plaque on behalf of the JJC**
 - **Josh shared overview of student: went from having straight A's to dealing with social/emotional issues, ended up going to the alternative school (Dream Academy) and flourished. Became an A/B student, started first job, working at Walmart while going to school.**
 - **School principal, Admin from Central Office, and this student's teacher all attended, along with this student and her mother**
 - **Finances: Treasurer is out on leave**
 - **JJC awarded grant for FY 2019 – approximately \$60,000**
 1. **Budget for FY 2019 will need to be approved through the county, beginning with approval through the Judicial & Public Safety Committee**
 - **JJC was not awarded 2nd grant opportunity – JJ Youth Serving Program.**
 1. **Requested \$26K to fund a facilitator for a Restorative Conferencing (Victim/Offender Mediation) program as a diversion option**
 2. **Informal feedback given by IJJC**
 - a. **Competitive – wide variety of eligible candidates**
 - b. **Did adequately explain how trauma and DMC would be addressed**
4. Old Business
 - JJC Logo Updates/presentation
 - **Maurice Martin presented to Board of Directors**
 1. **Developed 12 logos initially**
 2. **Narrowed down to 3 different logos with 2 variations**



3. **Wanted to show collaboration, symbolizes unity, collaboration, & support**

DISCUSSION:

- **Conduct an open poll to the larger Council at the retreat and Board can vote to ratify the majority vote to approve the logo**
- **Maurice shared that he has been working on the logos for about 3 weeks, about 5 hours each day**
 - o **Sherry added that she observed Maurice's commitment**
- **Skills learned by Maurice: working more with the program and how to talk to people in a business way**
- **Julia to coordinate with the family to have Maurice recognized at the retreat**
- **Feedback: make the center of Option #1 white so that when it is decreased in size, it will still stand out.**
 - **Mental Health First Aid Training Email Vote Report - shared**
 - **VOTE: Does JJC approve to fund \$4300 for the Mental Health First Aid training?**

APPROVED Unanimously

5. **New Business**

- **FY 2019 Grant Updates**
 - **VOTE: Does the JJC approve the proposed budget?**
- APPROVED Unanimously**

DISCUSSION:

- **Concern: are we going to have the same issue we did this year with last minute spending?**
 - o **Had to include proposed items, can still move money around if needed**
 - **Trainings were included based on proposals received**
 - **Both proposals were included in packet**



- Remaining Grant Funds Report
 - VOTE: Does the JJC approve spending \$3925 to purchase 150 Restorative Conferences Books to have available for use by the trainers?
APPROVED Unanimously

DISCUSSION: None

- Moving FY 2018 Grant Funds
 - VOTE: Does the JJC approve moving approximately \$3925 + \$394.68 (totaling \$4319.68) from the Personnel line item to Supplies line item to cover the cost of additional Restorative Conferences books and the excess cost of Resource Cards?

 1. VOTE: Does the JJC approve bringing the Wake Up Call training to Kane County in the Fall of 2018?

DISCUSSION:

- **Explanation: mockup of a teen bedroom, with 3 presenters (1 that is a family member of someone addicted to opiates/heroin, 1 that explains the drugs and walks through the teen bedroom and 1 that discusses parenting)**
- **Connected with Rosecrance**
- **Possibly host at the start of the school year**
- **Board to review proposal**
 - **Can we set up 2 opportunities – one at the north end and one at the south end?**
- **Josh to reach out to the districts with parent universities to see if this would be of interest.**

- Policing the Teen Brain
 1. VOTE: Does the JJC approve coordinating to bring Policing the Teen Brain to Kane County?

MOTION to TABLE the discussion

DISCUSSION:

- **Explanation: multiple options available, proposals for all are included**
 - **It would be up to the Board to decide which they would want to pursue**
 - **Options for both patrol officers and SRO's**
 - **Was discovered through a suggested by one of the partners from Elgin Police Dept.**
- **Funding – have \$25K from the new budget to put toward this opportunity**
 - **Would have to decide what to use it**
 - **Possibly partner with other sources of funding**
 - **Strategies for Youth indicated there may be interest from a local foundation in helping to support the training**
- **Pending legislation for SROs: Does this conflict with SB 2925?**
 - **Would require SROs to attend a 40 hour training**
 - **Need to better understand the training that SRO's go through first**

 - Changing Children's Worlds Foundation Facilitator Training
 1. VOTE: Does the JJC approve spending ~~\$400~~ **\$450** to send 2 facilitators to the Changing Children's Worlds Foundation workshop in June 2018?

APPROVED Unanimously

- **Proposal included**
- **Some interest at the schools in facilitating a group for teen parents**
- **Training workshop is toward the end of the month (6/21, 6/22, & 6/29)**
- **NOTE: Typo in the amount. Original vote read \$400, actually requesting \$450.**

- **Plan shared. In the past, JJC has participated in the event at the Sheriff's Dept only**
 - **Would like to expand and share materials**
 - **Board members to review and share ideas with Julia**

 - **Julia shared that the Info Sharing subcommittee has partnered with IT to put the Needs Assessment in an online format to increase efficiency**

- **Julia shared about continued attendance to Community Quality Council (CQC) meetings with the Dept of Human Services Family Community Resource Centers**
 - **Continued discussion around how JJC can benefit from participation and at the same time offer support to the CQC**
