- Fall/Winter Parent presentation: Internet Safety & Wake Up Call training
  - VOTE: Does the Board approve coordination for each of these proposed trainings?

Julia explained internet safety presentation: information about monitoring youth on the internet, speaker from Illinois Criminal Justice Information Authority – Director of the Targeted Violence Prevention Program. Still in the process of defining the content of the presentation. The purpose would be to educate parents about the risk of youth disconnecting from their peers and instead connecting virtually with online identities that could increase risk.

Wake Up Call: Dates are being pushed further out into February due to calendar. Would be an additional \$750 for the training to be done on two back to back days. JJC could consider adding a cosponsor to help off-set the cost. Looking for school district partners who are interested in hosting.

- Internet safety presentation question about covering gang violence versus the radical extremist violence, gang violence seems to be more prevalent: could include information about gang violence and how it compares, but examples provided of both occurring, the online connection may appear more discreet
