- Training updates

DISCUSSION:

- **Discussed whether or not this is something that the JJC wants to proceed with**
 - **Julia spoke with Commission to ask if we would be able to reallocate the funds if this is not something we want to do**
 - **Just need to discuss our plan for utilizing the funds with them**
 - **If shifting line items, will take a little more time, but still possible**
- **Chief Wieteska is going to look into this**



- **Training and Standards Board is reorganizing training**
 - **Different requirements needed to be SRO; have to do 40 hours of training already.**
- **Roughly 50% have juvenile training**
- **SRO's get it, would be more beneficial for patrol officers**
- **Chief notes the different units who provide regional trainings add different layers to training classes, tough to make time for blocks of instruction, would be helpful as a train the trainer to cover more officers and allow for flexibility.**

- **House Bill – SB 2925 is the bill which adds the SRO requirements**
 - **Wake Up Call**
 - **VOTE: Does the Board approve funding the cost of two Wake Up Call presentations in collaboration with District 304 and District 301 at a total cost of \$4500?**

- **Presentations will be hosted at Burlington Central and Geneva High School**
 - **Met with Burlington separately to discuss details**
 - **Have met multiple times with Geneva – representatives from Your Choice came down for a meeting**
 - **Brought a water bottle with to demonstrate how ordinary objects can be used to hide drugs and/or paraphernalia**
 - **Discussed overflow plan- both schools have confirmed that they will have space with closed caption television equipment to livestream**
- **Vaping has been a huge trend in the schools – requested that presentation cover some of this information**
- **Josh notes Your Choice will present information for parents on the science of marijuana**
 - **Issues with dabs another problem in schools**
 - **Wake Up Call – Youth Program**
 - **VOTE: Does the Board approve further negotiation to fund the cost of two student presentations in conjunction with the Wake Up Call presentations?**

DISCUSSION:

- **Board concerned because unlike adults cannot open those presentations to entire county. Do want to recognize the assistance from both schools in allowing us to use their facilities.**
- **Still trying to identify what will work for the school schedules, both have expressed interest and have requested 4 assemblies**
- **Wake Up Call quoted \$2500 for 2 presentations (usually \$1500 for one)**
 - o **Usually only do 3 presentations in one day, hesitant to do 4**
 - **Changing Children's Worlds Foundation request**
 - **VOTE: Does the Board approve moving forward with part 2 of the submitted proposal?**

DISCUSSION:

- **Identified two individuals from D131 to attend; later reported that only one of the individuals was able to attend half of the training in the summer**
 - o **Sought reimbursement for the individual who did not attend after receiving invoice**
- **Received request to move forward with the second part of the proposal: to cover the cost of facilitating a group for young parents**
 - o **Would be run by trained facilitator**
 - **Facilitator that the JJC provided funding for has not completed the training, despite reports that the individual would be attending later in the summer**
- **Board looking to complete part 1 before moving forward with part two. Board in agreement to reconsider at that point.**

5. New Business

- Needs Assessment Pilot Update
 - Pilot agency #2 changes
 - Children's Mental Health Grant

DISCUSSION:

- **Program Manager from District 131 has left her position**
 - o **Now in the process of hiring**
 - o **The district has reportedly moved the grant to the same department as the Project AWARE Program Manager and is making some adjustments to the structure of the program**
 - **Could impact their initial concerns around asking the red flag questions about self-harm/suicidal ideation – were concerned that they did not have staff equipped to manage after hours (during school hours, staff would just refer the youth to a school social worker)**
- **Health Dept's Mental Health grant has initiated discussion around utilizing a universal screening tool**



- **JJC will participate in discussions, sharing the Needs Assessment that has already been developed**
 - **Will keep Board of Directors apprised of updates**
