SB 2350: Public Act 100-0996

Provides that law enforcement must conduct an active shooter drill within 90 days in the school setting while students are present.

SB 3537: Public Act 100-0822

Provides that publicly funded early childhood programs receiving Preschool for All Block Grant funds or Preschool for All Expansion Block Grant funds shall collect and review its chronic absence data and determine what systems of support and resources are needed to engage chronically absent students and their families. Report will be made available to the State Board of Education and will be made publicly available.

HB 4442: Public Act 100-1043

Provides that school districts must include curriculum on parenting education for 9th to 12th grade students; includes, but is not limited to, instruction on (i) family structure, function, and management, (ii) the prevention of child abuse, (iii) the physical, mental, emotional, social, economic, and psychological aspects of interpersonal and family relationships, and (iv) parenting education competency development that is aligned to the emotional and learning standards of the student's grade level. Provides that this instruction is a prerequisite to receiving a high school diploma and shall be included in the Comprehensive Health Education Program.

HB 4658: Public Act 100-0903

Requires a school board to adopt and implement a policy on how to recognize mental health issues and how to properly address them. Also provides that a school board shall require in-service training of licensed school personnel and administrators to include, at least once every 2 years, training on the current best practices regarding the identification of and recommended courses of action for mental health issues.

HB5786: Public Act 100-1035

Provides that an in-school suspension program provided by a school district for any students in kindergarten through grade 12 may focus on promoting non-violent conflict resolution and positive interaction with other students and school personnel. This is not a State mandate.

SB 2951: Public Act 100-1016

Creates the Early Mental Health and Addictions Treatment Act. Requires the Department of Healthcare and Family Services, and other specified agencies and entities, to develop a pilot program under which a qualifying adolescent or young adult may receive community-based mental health treatment from a youth-focused community support team for early treatment that is specifically tailored to the needs of youth and young adults in the early stages of a serious emotional disturbance or serious mental illness. Pilots will be implemented across geographic regions around the state.

HB 4887: Public Act 100-0680

Provides that DCFS will assist youth in care to obtain essential documents to function as an independent adult (driver's license, social security card, medical and educational records, etc.) prior to being terminated as a ward under Juvenile Court Act.

SR 1774

Creates the School Discipline Reform Task Force for the purpose of assessing the implementation of the school discipline reform legislation passed in 2015, Senate Bill 100 (Public Act 99-456), and making



recommendations to address any ongoing challenges related to the overuse or misuse of exclusionary discipline and what has become known as the "school-to-prison pipeline".
