Discussion:

- Focus area: supporting law enforcement and interactions with youth
 - Initially considering Strategies for Youth a program out of Massachusetts
 - Also discussed training that is currently offered; resource officers get more training than patrol officers.
 - Action plan steps focus areas identified at the beginning of the fiscal year; still need to be addressed.
 - Trauma/Social Emotional Learning

Idea for a mental health training similar to format of Wake Up Call – to increase awareness among parents

- Possible to collaborate with the Children's Mental Health grant through the Health Dept.
 - a. Schools are aware of the signs, but would be helpful to have next steps

Youth Involvement

Initial discussion to do a Youth Advisory Board, but open to other ideas.

Supporting Law Enforcement

Reviewed initial idea to pursue Strategies for Youth (based on feedback from law enforcement partners), but does not seem feasible.

DISCUSSION

 - Impact of work on mental health of officers
 - Impact of trauma on behavior
 - Community outreach with juveniles
- Kristen to JOA for more ideas
- Awareness/understanding of complications from juvenile law
 - Following legislation keep membership updated about current issues impacting law enforcement
- SAO working on juvenile expungement law update and presenting at JOA
 - Rachele provided updates for the packet
 - JJC Student Award 2019
 - Materials are being finalized

DISCUSSION

- Kane County Bar Association has agreed to provide a donation for the scholarship again, but inquired about a potential match by the JJC from fundraising efforts
 - Concerns about the capacity to do so
 - Will continue to discuss
- Julia has emailed County Board to request same set up as last year versus doing a resolution
- Want to get materials out beyond the schools
 - Wake Up Call Presentation
 - 3rd School District: U-46 Updates
 - Review from events survey feedback shared
 - **Results provided in packet**

- Attendance impacted by weather
- Provided an example from a conversation at the presentation parent said that every parent needs to know this information
- Comments were positive
- Wake Up Call received calls from other school districts/communities
 - o Julia and Sarah will be meeting with U-46 (Elgin HS and Larkin HS) on March 1st
 - Also trying to coordinate with West Aurora
- Student presentations Sarah observed freshman presentation
 - Provided 4 perspectives about the impact of addiction
 - Asked students at the end to stand up if they had been impacted by addiction
 - IJJC Site Visit

Formalized plan for data – currently reviewing the draft

DISCUSSION

- Reviewed purpose: to gather more accurate picture of juvenile contact with law enforcement
- Plan to be more globally focused
- Once finalized, will submit to the judiciary and then to the Chiefs of Police for more information
- Have received some input so far from Judge Abrahamson able to do something similar for abuse/neglect, but framework was already established
 - JJC is now creating something from scratch

 - Wake Up Call Presentation 4th School District: 129
 - VOTE: Does the Board approve further negotiation and coordination to host two additional Wake Up Call presentations in collaboration with District 129?

 - Restorative Practices: additional training opportunities
