- Approval of minutes from April

# Result: APPROVED as distributed

- JJC Chairman's report
  - Figuring out meeting times and location for next fiscal year
    - Would like to have video conferencing option
    - Will send out a poll
    - Brief discussion of existing county meetings & available days
  - Awarded the grant for FY 2020
    - Reduced from the requested \$65K to \$50K because IJJC will help with proposed police trainings
    - Lisa shared about presenting DMC data at Judicial & Public Safety meeting
      50% of juvenile arrests are coming out of Aurora
  - News article featuring 2019 Student Award winner Ivan Carmona
    - Board also made aware that Ivan has also received some negative feedback as the recipient of the award
- Old Business
  - Website pages
    - Drafted pages for Student Award, Professional Award, legislative updates, and cultural competency distributed for consideration

    - Update on website homepage one of the features is no longer available at no cost; will work with IT to adjust

After Board provided

approval, learned that officers had paid up front, making it difficult for JJC to reimburse tuition/fees. Therefore, JJC cannot provide funding for this initiative this year.

- **Restorative Practices Training Update** Working on final details - Health Dept/Children's Mental Health grant coordinating lunches. We have a waitlist of approximately 25 people. Need to order materials ASAP - have not received enough responses for the email vote to pass.
- **Diversion Resources portal** Julia continues to work with county IT on this idea. Have said a portal is possible, but the password protected part could create some challenges.
- New Business
  - Email Vote: ROE Grant Letter of Support • Email vote record provided; ROE requested JJC support for a grant to provide funding for school safety technology, supplies, and professional development as requested by the districts.
  - Email Vote: Restorative Practices Additional Expenditures Email vote record provided; need additional votes in order for it to pass.
  - Domestic Violence cards
    - VOTE: Does the Board of Directors approve spending up to \$750 to purchase • approximately 7000 of the domestic violence cards?

After review of juvenile data – disproportionate number of girls committing domestic violence. State's Attorney McMahon wanted a domestic violence card for victims, officers, etc. Draft of the card presented to Board of Directors; trying to cover both needs of JJC and State's Attorney's Office.

Initial concerns: need to address the difference between intimate partner abuse and youth/parent violence. Include CCBYS, SASS numbers.

- There is money in the budget for this due to the decision not to move forward with the police training



• Card was drafted and reviewed individuals who are trained in IIRP

 Books to help teachers incorporate circles into the classroom, requesting purchase of 9 for each district, school districts are sending individuals to restorative practices training

  - The book is recommended by one of the districts
  - Have at least half of the districts confirmed for the training
  - Per Senate Bill 100 schools are expected to keep kids from getting suspended and eventually mitigate behaviors
    - Restorative practices are being implemented to help with this
- How will we distribute?
  - Contact up until this point has been Director of Student Services
    - Reviewed experience with law enforcement cards
    - Could schedule a meeting to introduce both the cards and the book
  - FY 2020 Grant
    - VOTE: Does the Board of Directors approve the amended budget? Reviewed amended budget with awarded amount (\$50,000) for FY 2020
