#### Juvenile Trends

Members provided input on juvenile trends from their agencies

- Mental health needs 50% of juveniles with a diagnosis
  - Increased need of mental health services
    - Increase in serious mental health issues hospitalization difficulties
      - Overutilization of law enforcement/emergency room for mental health intervention
    - Increase in juveniles needing crisis assessments
    - Decrease in undocumented families accessing mental health services due to fear of deportation dropping kids Medicaid, kids cannot access services
    - Increase in more significant mental health symptoms for teens that are presenting for assessment/treatment
- Children of substance users with mental health issues
- Increase request for residential programs
- Grandparents raising children (home instability)
  - Kids separated from parents/family support due to immigration, incarceration, substance use/death, mental health issues/institutionalization, family violence, DCFS involved/foster homes/adoption
  - $\circ$   $\,$  Children not placed with bio parent  $\,$
- Waitlist to receive services
- Exposure to trauma
  - History of sexual assault that is unaddressed 50% to 80% report
  - Increase in sexual acting out behaviors toward female staff
  - Issues with school
- Family member who is mentally ill
- Trauma reactions
- Who youth are hanging out with and their attitude
- School threats
- Unable to cope with rejection
- Anger management
- Recidivism
- Aggression around cell phone use
- Violence against parent/sibling
  - Domestic battery against parents
- Lack of mentorship, professional development, coaching, career exploration
- Increased violence between youth
- Increased incidents of serious staff assaults
- Violation of probation curfew
  - Children refusing to go home (summer), wanting to stay out because it is summer
- Drug use
  - Start using marijuana, engagement in community supports declines
  - Drug use contributing to recidivism
  - Younger children until 13 with substance use issues



- Increase in opioid use, overdose and death negative impacts on youth, adults & families, pregnant women
- Less admissions/referrals to treatment for teens from Court Services for marijuana because of how it is viewed/handled vs a decade ago
- Increase in school refusal leads to excessive absences, home-schooling, effects graduation rate
- Suicide
- Parental refusal of services
- Increase vaping @ schools causing discipline issues
- Increase awareness and attention on youth issues including mental health
  - Polarized relationships with community and law enforcement interferes with progress
- Violence, random acts to strangers

#### Youth/Parent Domestic Violence Discussion

Contributing factors

- Parents don't know how to parent
- Parents absent from home
- Other priorities/pressures from home
- Generational differences
- Difficulty controlling anger/emotions
- Media influences and more violent trends

## Strategies

- Empower and educate parents about what they can do (Ex: can remove cell phone)
- Parenting classes/healthy parenting skills
- Emotional intelligence and emotion regulation
  - Restorative practices
- Alternative communication strategies for parents who are unable to attend training (PSA's)
- Educate parents about community resources through existing opportunities (school registration)
- Review best practices/case studies of other places that have successfully addressed DV issues
  - DuPage Step Up
  - Bloomington programming specific to girls
- Breakdown demographics of who is committing DV's and target interventions
- Coping mechanisms/resources for youth themselves, guidance for youth in the interim before getting to professional care



### 8. Legislative Updates

## SB 0901 – Expands qualifying time for individual care grant, sent to Gov.

- A child will continue to be eligible for ICG if the child is placed in the guardianship of DCFS b/c child requires care in a residential facility. Wardship concerning neglected, abused, and dependent minors terminates at 21 years of age rather than 19.

### HB2649 - creates taskforce on Children of Incarcerated parents, sent to Gov.

- First meeting held no later than August 1, 2019. Taskforce shall review available research, best practices, and effective interventions to formulate interventions. Report of findings and recommendations should be submitted to the General Assembly and Governor by 12/31/2019.

# P.A. 101-0018 – Police & Hotel Employee Training in Identifying Human Trafficking, expanding statute of limitation for Human Trafficking

- All law enforcement officers must take human trafficking training
- Amends criminal code: Provides that when the victim is 18 years of age or over at the time of the offense, a prosecution for involuntary servitude, involuntary sexual servitude of a minor, or trafficking in persons and related offenses may be commenced within 25 years (rather than 3 years) after the commission of the offense.
- By June 2020, hotels and motels must train employees in the recognition of human trafficking
- Department of Labor shall develop curriculum for training

#### HB1579 – Mental Health Evaluations for Minors, sent to Gov.

- Prior to a sentencing order for disorderly conduct by making a threat of destruction of school building, property, or a threat of school related violence, the court may order a mental health evaluation.

#### HB3704 - Post-Release Services to Juveniles in DOC care, sent to Gov.

- Services provided by the Department of Corrections for transitional and post-release treatment programs for juveniles committed to the Department shall include family engagement, including, but not limited to, visitation and programming.

# HB3086- Extension and Expansion of Purview of the Emotional Intelligence and Social and Emotional Learning Task Force, Sent to Gov.

- Must include strategies and instruction to address the needs of students with anger management issues in their best practices
- Must also make recommendations of funding sources
- Complete guidelines and recommendations by March 1, 2020 (as opposed to January 1, 2019)

## HB1551 – DCFS Aftercare, Sent to Gov.

- If children are returned to parents, DCFS or service agency shall provide a minimum of 6 months of aftercare services to each child beginning on the date that the child is returned home. Requires the Auditor General to begin a performance audit of DCFS on year after the effective date of this act to determine if DCFS is meeting requirements.

#### HB0831 - Child Abuse Reporting, Sent to Gov.

- Requires DCFS to notify Department of Public Health and Healthcare and Family Services of reports of abuse that occur in facilities operated or licensed by DPH or DHFS and provide them with findings.



## SB1239 - Review of Reports of Neglect to DCFS - Sent to Gov.

- Prior to classifying a report of abuse/neglect as unfounded, DCFS must first determine whether report is subject to review and must complete the review process prior to classifying the report. Requires a review of a random sample of at least 5% of child abuse and neglect reports

#### HB2256 – Emancipation of Minors – sent to Gov.

- Order of complete or partial emancipation may be entered even if there is an objection by the minor's parents/guardians and court finds that emancipation would be in the best interest of the minor.

#### HB2983 – Youth Homelessness Prevention, sent to Gov.

- Requires creation of Youth Homelessness Prevention Subcommittee to drive strategic vision for preventing homelessness among youth leave state systems of care.

#### SB1808 – DCFS Transitioning Youth, sent to Gov.

- To prevent homelessness, incarceration, unemployment and other similar outcomes, DCFS shall enter into an interagency agreement with specified agencies for the purpose of providing preventative services to youth in care and young adults who are aging out of or have recently aged out of the custody/guardianship of DCFS. Requires establishing an interagency liaison to review cases of at-risk youth in care and young adults, connect such youth to appropriate services to establish stabilization. Determine how to best provide housing, education, and employment services to at-risk youth in care and young adults. Requirements annual reports to General Assembly.

#### HB2152 – Mental Health Action on Campus, sent to Gov.

- Creates Mental Health Early Action on Campus Act. In order to raise mental health awareness on college campuses, each public college or university must complete specified tasks.

  - SASS completed over 2000 assessments last year, including adults over 22
     More deflections than hospitalizations, with the exception of June
  - Central States SER: Non-profit focused on career development for youth with barriers, located in downtown Aurora
  - Workforce Development Division Youth Services added a new provider: Parent Alliance Employment Project
    - Focused on youth with disabilities from ages 16 to 24
    - Work 1:1 with youth at Delnor hospital
