- 3. JJC Chairman's report
 - Follow up on DHS request to Health Department regarding the JJC grant for missing reports Sarah reached out again earlier this week and submitted the two forms that were missing.
 - Financial:
 - Treasurer provided county budget form, Sarah will get monthly expenditures to Board
 - Anticipating a reduction in personnel due to coordinator being on temporary leave
 - Still at about \$43K as of November
- 4. Old Business
 - De-Escalation Workshop
 - Received a speaker recommendation from Dr. Graczyk a colleague from UIC, Dr. Marc Atkins
 - He is a professor of Psychiatry and Psychology, Director of the Institute for Juvenile Research, and Director of Community Engagement and Collaboration
 - Will also take other suggestions
 - Youth focus groups
 - Need to get questions to Josh to review prior to setting them up.
 - School Discipline Roundtable Discussion
 - Planning for March/April
 - Would like to add a school safety component covering threat assessments to help address misconceptions about threats to safety within the school setting based on research



- Question: Is there a standard protocol for discipline?
 - Not consistent, most schools have a matrix based on guidelines from the State Board of Education, but usually individualized
- Josh requesting input from education personnel (administration) who will be invited to attend the workshop
 - Question that has already come up How can school systems work better with juvenile justice system?
- Planning day of logistics:
 - ROE providing lunch
 - Hosting in the juror's lounge or Saint Charles Police Department (community meeting room, can host approximately 75 people)
 - Discussed including a tour of the JJC as well
- Law Enforcement Training
 - Have not heard anything further from ICOY
 - Lisa will reach out to local experts Lisa Jacobs
 - State's Attorney McMahon visited all 3 roll calls to talk about domestic violence
 - Seemed to get a good response
 - Sarah putting together something to do at roll call will attend as an Assistant State's Attorney
 - Send any ideas
 - Explain the crisis cards
 - Talk about SASS
 - FSA hired social worker for APD
- Handle with Care program

- District 129 is implementing with APD, FVPD, KCSD, NAPD
 - An email will be sent by the officer to Marti Neahring, Director of Student Services and Kevin Triplett, School Safety/Residency Officer.
 - Will also likely include the SRO
 - Email will simply say the student's name and "handle with care"
 - Police will notify the district after responding to a call that could be traumatic for any of the kids who are present
- **DISCUSSION:**
 - Adding probation to the list to be notified ideally school districts would have a working relationship with probation officers
 - Can parents stop it? No
 - Josh talked to principal from Cicero for feedback positive reviews
 - Could also feature Marti/District 129 at School Discipline Roundtable
- Youth Mental Health First Aid trainings
 - Would be helpful for law enforcement/SRO, but need the training requirement that fulfills the training credit for department to send anyone.
- Restorative Practices
 - Restorative Question Cards Re-Order

DISCUSSION:

- FSA has been able to raise everything but \$5000 of the total cost for Juvenile Justice Jeopardy (\$17,500).
- FSA shared questions that were developed by Strategies for Youth for the game
 - o Sarah sending out questions to the Board of Directors for additional review
 - Concerns about the tone of questions and how they will foster relationships between law enforcement and youth
 - Also seems to leave certain parts out
- Where is this going to be done? Who will facilitate? Who will this be presented to? Will they have anyone to present to?
 - In order to spend funding, need to know how this may benefit FSA
 - Sarah will send Bernie questions to help Board make decision
- FSA shared concept with Kiwanis club and received a good response
- Can we offer to provide funding once presentations have been set up in the community?
 - Would likely not be helpful have to pay up front



Other Updates:

- Is there any further discussion about expungements training? DISCUSSION
 - In the past, there was discussion to do this with the Law Library
 - Questions about running LEADS in order to complete expungement other communities have had a liaison from ISP attend
 - Have tried to ask Prairie State to do a training in the past for attorneys, offering CLE's
 - Hired someone under a grant to help with expungements
 - \circ $\;$ As of January 1, police departments are responsible to handle auto-expungements
- Push at the state level to no longer detain pre-teens
