Financial

Expungement packet – updated in September. There has been request about the packet being translated to Spanish. Interpreter from the Public Defender's Office is currently working on translating. Will distribute when complete.

Update on data presentation from the Commission

- Julia setting up a meeting with Shawn Freeman Data Project Coordinator who provides the data for the different decision points. Will coordinate a time for a presentation with those interested and discuss information to be shared.

- Updates on priorities
  - Youth Focus Groups

Josh and Julia met with West Aurora. Julia meeting with the Director of Equity on Thursday afternoon. District already working to pull together some youth for discussions and willing to collaborate with JJC.

No response from U-46 as of right now.



 $\circ$  De-Escalation Videos

Content still being developed.

- Discussed making the training to be more interactive. Julia shared about online trainings/workshops that turn training into a game format.
   OUTCOME: Need more information about what that would look like in order to consider further.
- Julia also meeting with Pam from Court Services as well to get more perspective about the youth in detention committing these offenses. May facilitate a focus group or ask some of the questions to gain more perspective.
- Law Enforcement Training

Civil still looking into private funding source (Motorola)

o Parent Engagement

No updates – waiting for report to be completed by Health Dept for Court Services to determine next steps. Delays due to COVID tracking.

o Restorative Practices

Update provided - Interest in reconvening; will set a meeting in January after the holidays to explore how we can provide support virtually.

- Two districts participating (U-46 and D300) are both remote right now.
- Partner from D300 is offering a virtual training to staff. May consider proposing some virtual training opportunities to keep trying to get people trained.
- Racial and Ethnic Disparities
  - Meeting on 12/18 with Court Services & ROE to continue discussion
  - Survey for law enforcement has been put into a Google Form for distribution and letter has been drafted and sent for review. Discussed distribution.
    - Commander Frieders will make announcement at Chiefs of Police. Julia will draft a letter and share to be distributed following the announcement.
    - Julia will compile materials and construct an email to make the request.
- Individual Meetings
  Follow up from discussion at the last meeting to discuss JJC structure.
  OUTCOME: No changes made. Julia will focus on meetings with the active members.
- ACES Interface training

**Continued discussion:** 

- Reaching the halfway point of the fiscal year and still have a significant amount of funding left unspent.
- **Reviewed options:** 
  - Services for youth on probation Lisa will look into any outstanding needs
    - MST slots availability fluctuates based on needs of community and Delinquency judge
    - Need Spanish speaking therapists
  - Supporting diversion options
    - Juvenile Justice Online
      - Question about offering scholarships to cover the cost of the participating in the program
        - Some police departments are using this.
        - Concerns: private business, cost of the program is more than the citation
      - Would need to determine how to utilize funds (i.e. lump sum to police departments or program itself)
      - Offer a suite of interventions to match the need w/ the intervention
        - Officers match needs of youth based on discretion there is no risk assessment to identify the needs of the juvenile
      - Kristen looking into other programs being used by other departments
