- Appreciate the idea of seeing the numbers compared to other jurisdictions
- Julia to send out recording for others to distribute throughout their network
- Question about arrest data and where we are at left off with considering a proof of concept versus collecting from all agencies. Included in the grant application. Question about including all contacts/interactions between youth and law enforcement not all are documented, have narrowed down documentation due to expungement law. Members in agreement that it would be helpful to have arrest data to show comparison between cases being station adjusted and cases being sent to Court Services.

Distributing agency flyers

 Received a request to distribute an agency flyer that listed the office of an elected Senator. Approval was given to send out the flyer. Confirmed that the JJC can send out information, so long as it is not a campaign. There are some elected officials that are supporting efforts/community providers. No comments about shifting current operations.

• CCBYS Grant Support Discussion

- Discussed request from Aunt Martha's to provide a letter of support for their grant application.
 - Should not be picking between agencies
 - Concerns about supporting agencies when there are discrepancies in the outputs
 - Decide on a case by case basis
