JJC Restructure

Workgroup met to review purpose of restructure and considerations. In preparation for the next meeting, the members will review JJC statute. Next meeting set for 9/19 at 12 PM. Will likely extend beyond October.

Workgroup met on Wednesday – began discussing themes/structure and location. Julia working on location options before next meeting; workgroup to reconvene on October 4th at 1 PM to finalize a theme and determine speakers.

JJC RED Team

Next meeting scheduled for 10/19. At last meeting on 8/17, discussed the 2019 data and determined additional data that would be helpful in determining next steps. LaTanya provided an update that they were able to pull some of the additional data and will share at the next meeting.

IRJEC (Statewide Committee)

Finalized plan and submitted to OJJDP. Prior to next meeting at the end of the month, will need to refine the criteria used to prioritize which jurisdictions to try and work with in reducing racial and ethnic disparities. Also determining workgroups needed to carry out the plan. Kane may be one of the jurisdictions that is selected based on the criteria.

ADB Workgroup

Julia reached out to Jamie to see about reconvening the group.

5. CPRD Presentation

Julia has seen a preview of the presentation. Provided a brief overview of the presentation - compares data from 2020 and 2021 related to detention, including the top 5 offenses and average length of stay. Also some data related to warrants and domestic battery offenses, as the top 2 offenses for admission to detention. Discussed whether or not to make part of the Board meeting or separate; preference would be to keep it separate. The presentation will likely be 30 minutes long with the remainder of the time for discussion, so looking for an hour block of time. Julia will send out a Doodle poll to get the most available date.
