Updates on FY 2023 Priorities

## JJC Restructure

Work group is working to reschedule. Shared plans for discussion at the next meeting, examining the purpose of the JJC and how it has been useful to those who are involved, specifically within their job function. In other words, is the JJC fulfilling a specific purpose that is worth maintaining or has it become just another meeting to attend that can be easily missed? Given the nature of this discussion, invitation will be extended to the Board of Directors as well.

## JJC Symposium Planning

Julia has been meeting with speakers around topics discussed within the work group and provided a preliminary overview. It would be a 4 part virtual speaker series of 1 hour sessions for those working with youth in Kane County who might be risk for system involvement. Will also look into continuing education credit; JJC Zoom Account can host up to 100 participants. It will be 3 speakers, with one of the speakers doing a 2-part session; Julia will gather bios to share with the Board. Discussed potential days/times – lunch hours are best if scheduling sooner, could also do toward the end of the day if planning further out. One of the speakers is looking to review some of the disparity data that has been reviewed; Julia will send out an email vote to approve what will be shared.

• Racial and Ethnic Disparities

JJC RED Team

Part of the team met at the end of November. Discussed some of the current offenses happening in schools and began reviewing the results of the law enforcement survey, which led to a discussion around considering the effectiveness of interventions with those that may not complete their station adjustments or may reoffend while there are efforts to divert. Looking to reconvene in the new year to identify next steps/focus.

## **IRJEC (Statewide Committee)**

Will reconvene the whole committee in January. The TTAS work group met to continue outlining the TTA process in preparation to work with Lake and Madison county in the new year. The second work group focused on improving data collection will meet in the new year, but potentially have some reflection to assist with preparation.
