- 3. JJC Chairman's report Financial Update
 - January: \$1,041.25 (Personnel and benefits)
 - YTD: \$\$11,292.63

Funding update: Kane County JJC is behind in spending as compared to other grantees. Discussed strategies that the Commission is looking into in order to account for the 20% funding cut as a result of being deemed noncompliant.

 - Updates on FY 2022 Priorities
 - Youth/Parents
 - Julia was reconnected with Myla Roundy. She suggested we use existing opportunities within the schools to connect with youth - West Aurora has offered some "lunch and learn" opportunities. Julia met with West Aurora and provided details - lunch is brought in by who is hosting the lunch and learn for 4 lunch periods. Each lunch would be capped at 25 students and be filled on first come, first serve basis. The purpose would be to connect with youth from West Aurora to talk about what the JJC is and how they may get involved; will also work with Myla to develop an agenda. The lunch and learn would take place ideally at the end of



March/early April. Eric offered to join but suggested having the West Aurora liaison officer there as well. Julia and Rachele to work with Myla to put together an agenda.

- Still waiting for the Commission to make connection with youth who is on the statewide Youth Advisory Board. Communication has been sent.
- Julia put together a flyer to solicit youth who may be interested in participating with the JJC that will be shared with those youth who participated in the county Youth Voices Forum discussing mental health. Also received interest from IDJJ in connecting with youth who are Kane County residents.
- Julia also planning to attend a Parent Council meeting in April to share about the JJC

o Parent Equity Workshop Update

The format of the second part was adjusted in light of feedback from the first session. It was requested that the information be brought to educators and there was a low turnout from parents. Instead of another evening parent work shop, 2 professional development sessions were offered for educators.
