#### 5. New Business

• Status of funding

Julia provided a recent update from the Commission – it appears that the initial communication regarding funding being discontinued was incorrect. There are intentions of issuing a Notice of Funding Opportunity for JJC's. Board discussed how to move forward, as the SAO is not in a position to continue the funding if the grant is not available or awarded. Need to determine an appropriate entity to oversee the JJC at this point. Consider exploring the option to do a blend of funding from the stakeholders on the Council and utilizing the grant to increase sustainability. Julia will provide a basic budget to Rachele to support follow up conversations.
